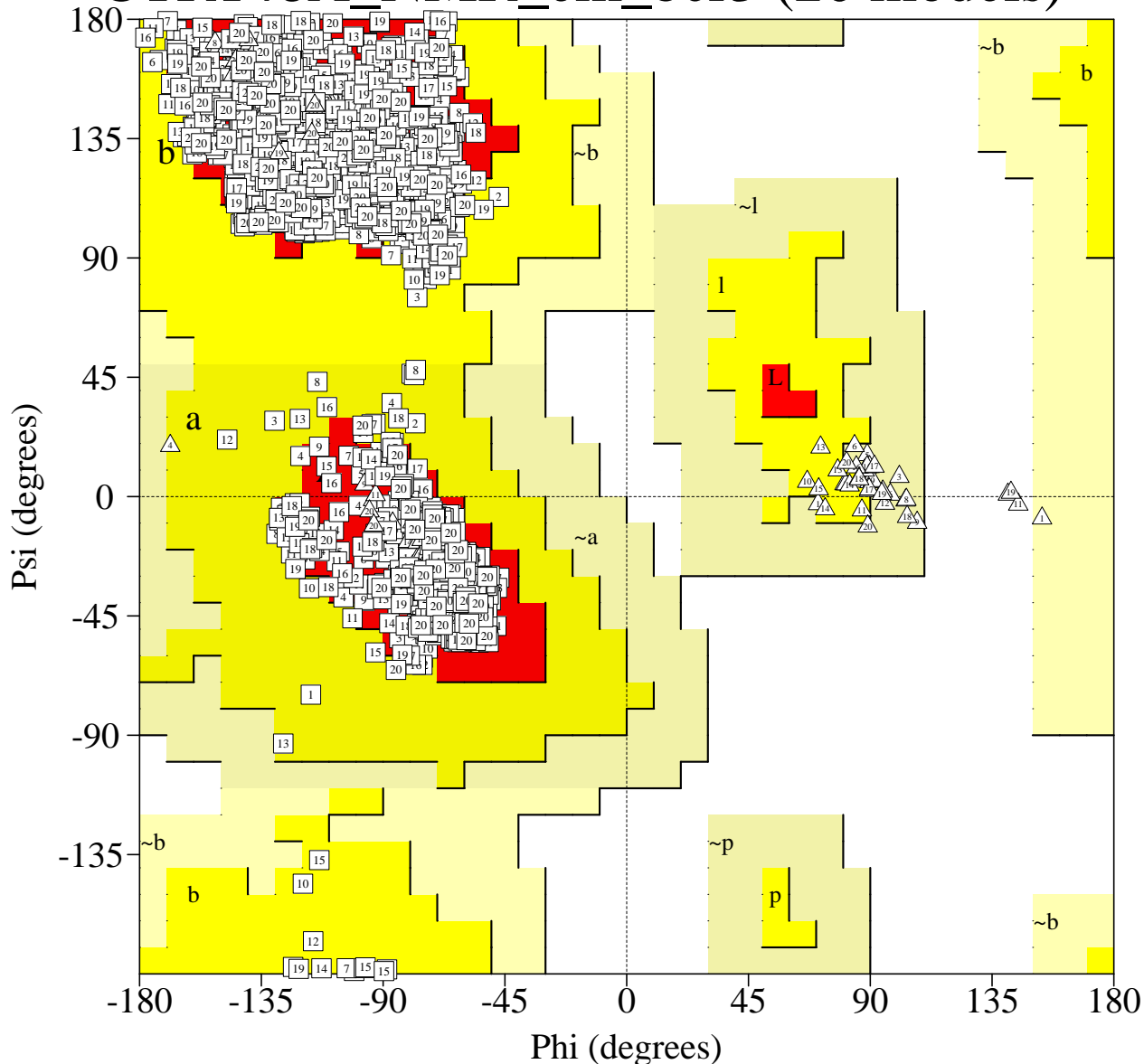


Ramachandran Plot
