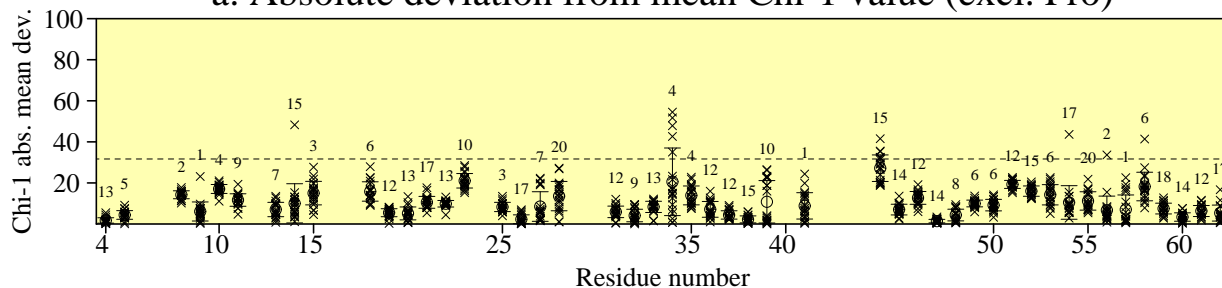


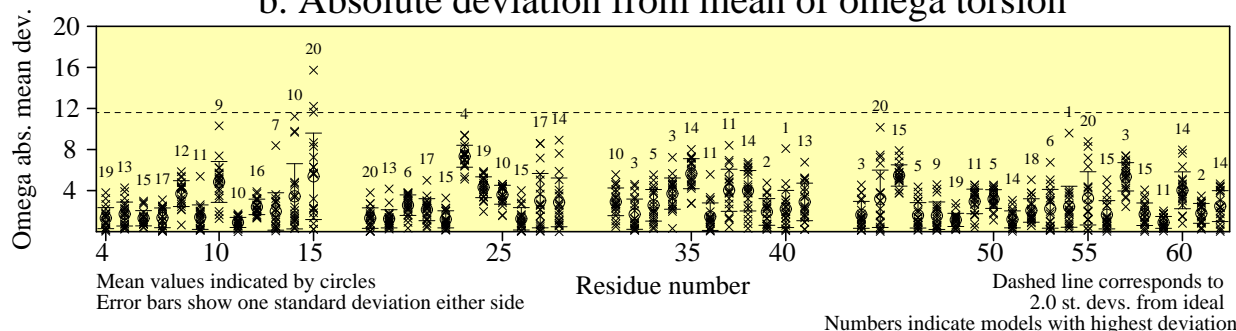

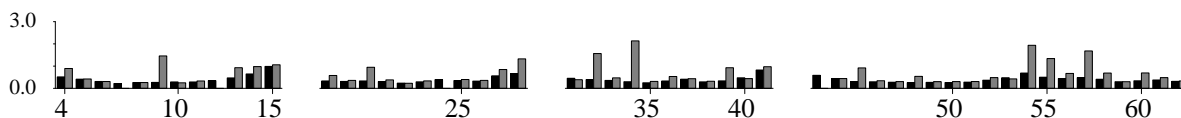
a. Absolute deviation from mean Chi-1 value (excl. Pro)



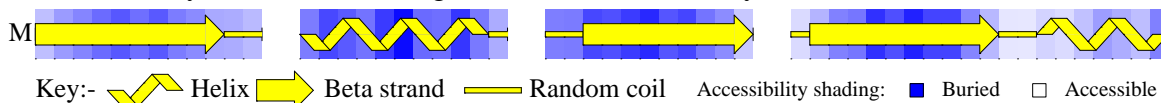
b. Absolute deviation from mean of omega torsion



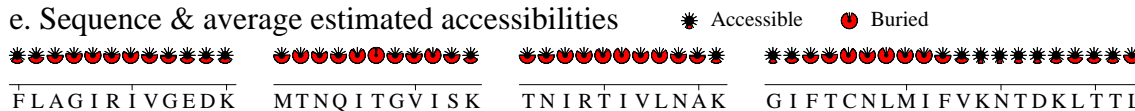
c. RMS devs from mean coords: main-chain (black) and side-chain (grey)



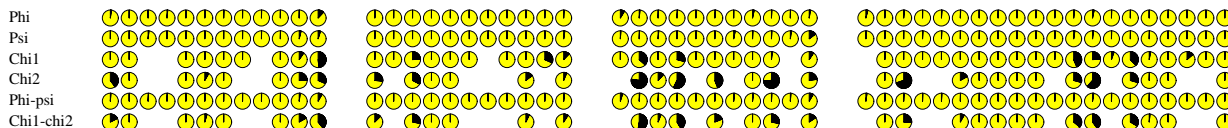
d. Secondary structure & average estimated accessibility



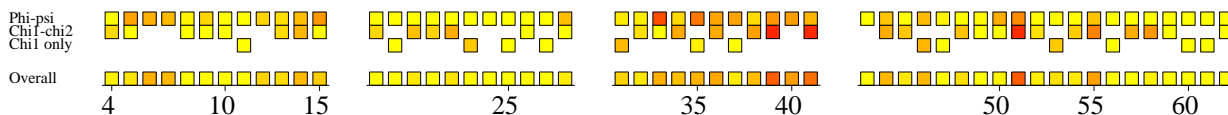
e. Sequence & average estimated accessibilities

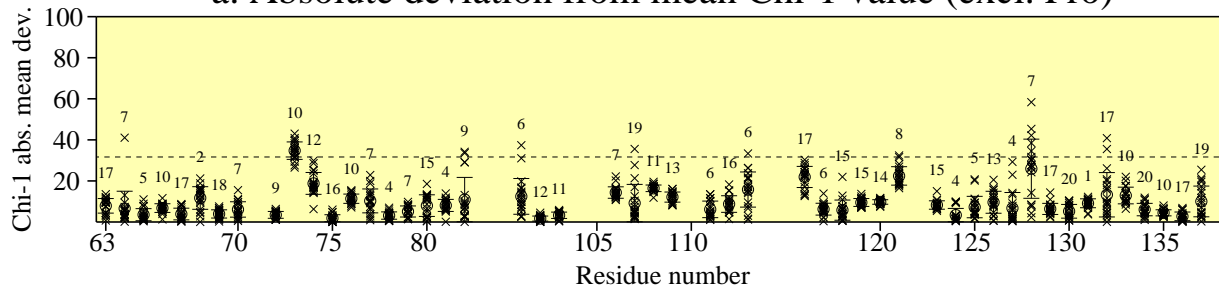

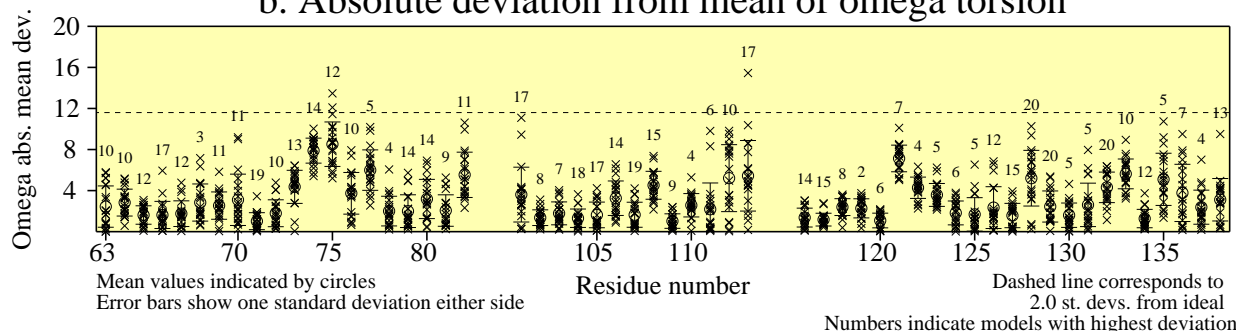

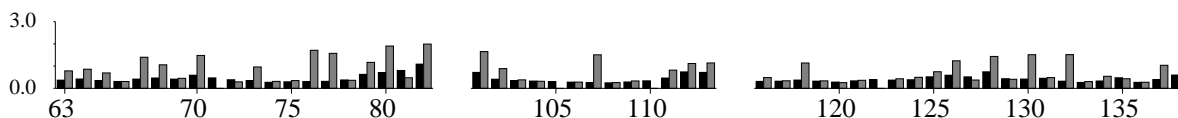
a. Absolute deviation from mean Chi-1 value (excl. Pro)



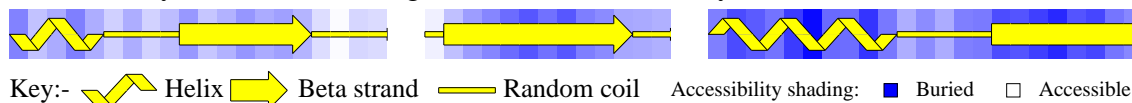
b. Absolute deviation from mean of omega torsion



c. RMS devs from mean coords: main-chain (black) and side-chain (grey)



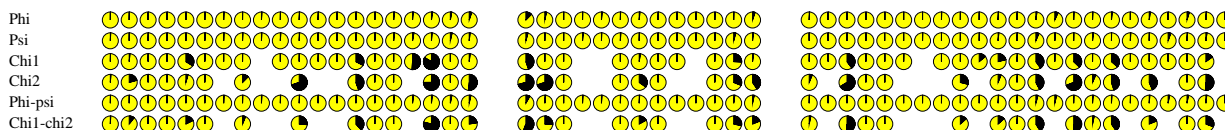

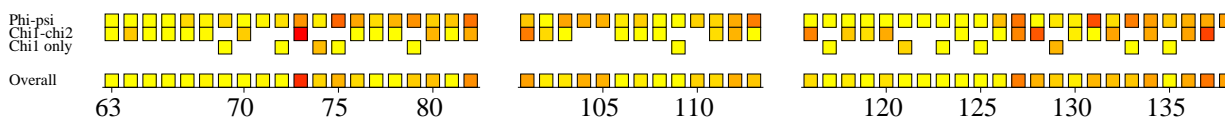

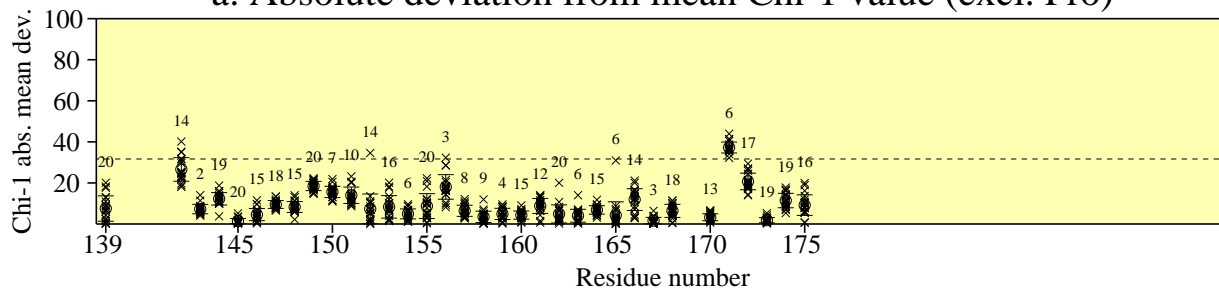

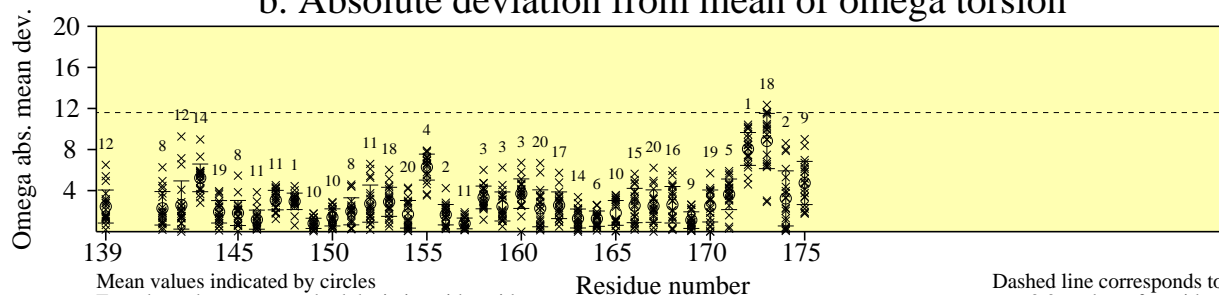

a. Absolute deviation from mean Chi-1 value (excl. Pro)

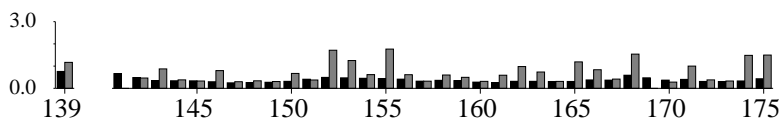


b. Absolute deviation from mean of omega torsion

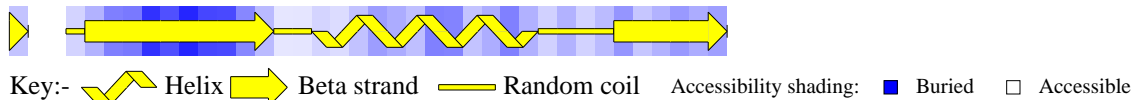


Mean values indicated by circles

 Numbers indicate models with highest deviation

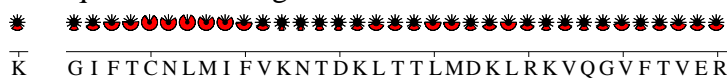
c. RMS devs from mean coords: main-chain (black) and side-chain (grey)



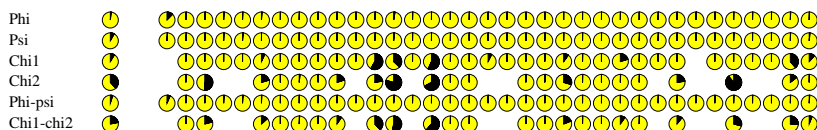
d. Secondary structure & average estimated accessibility
