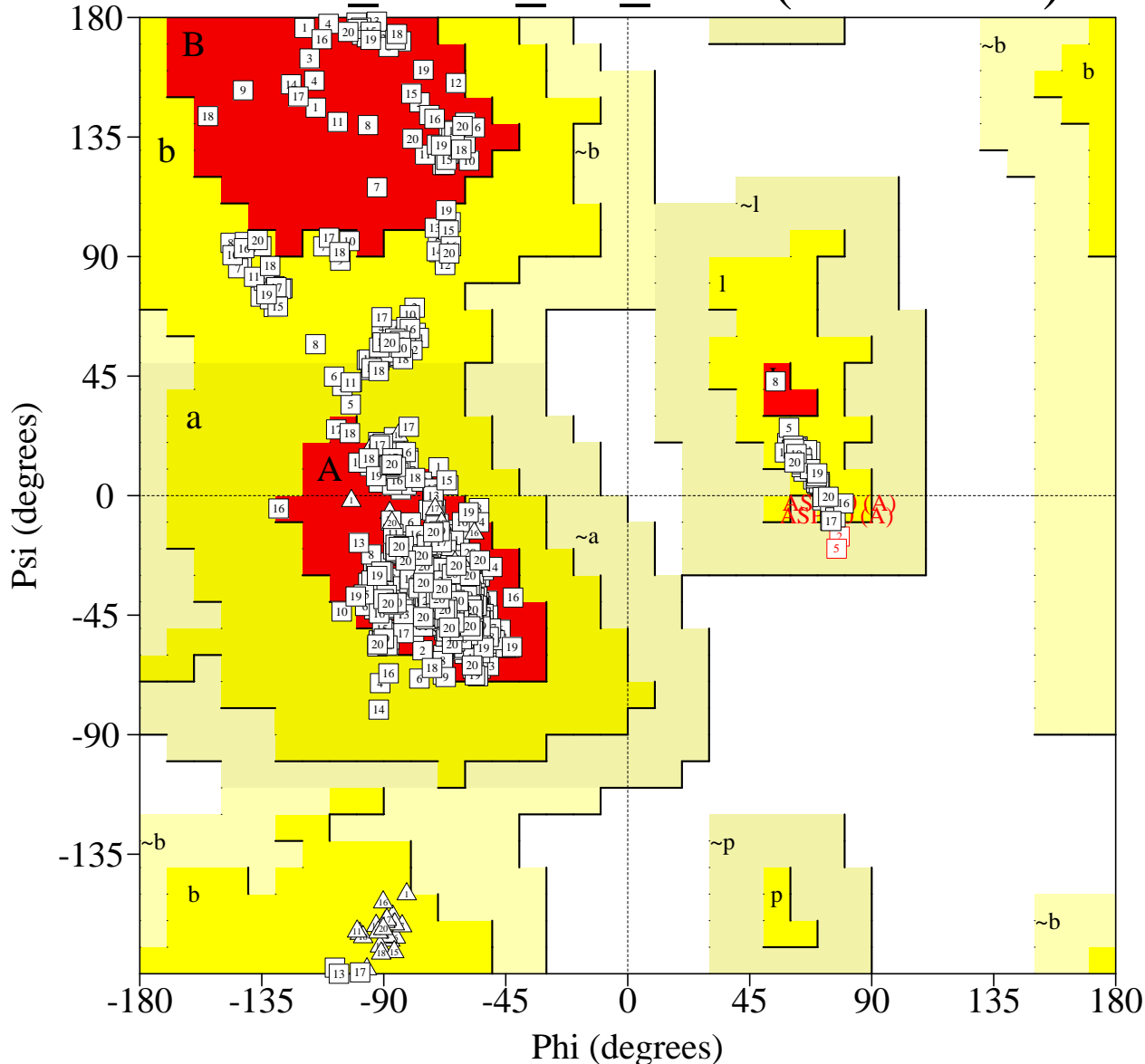


Ramachandran Plot
