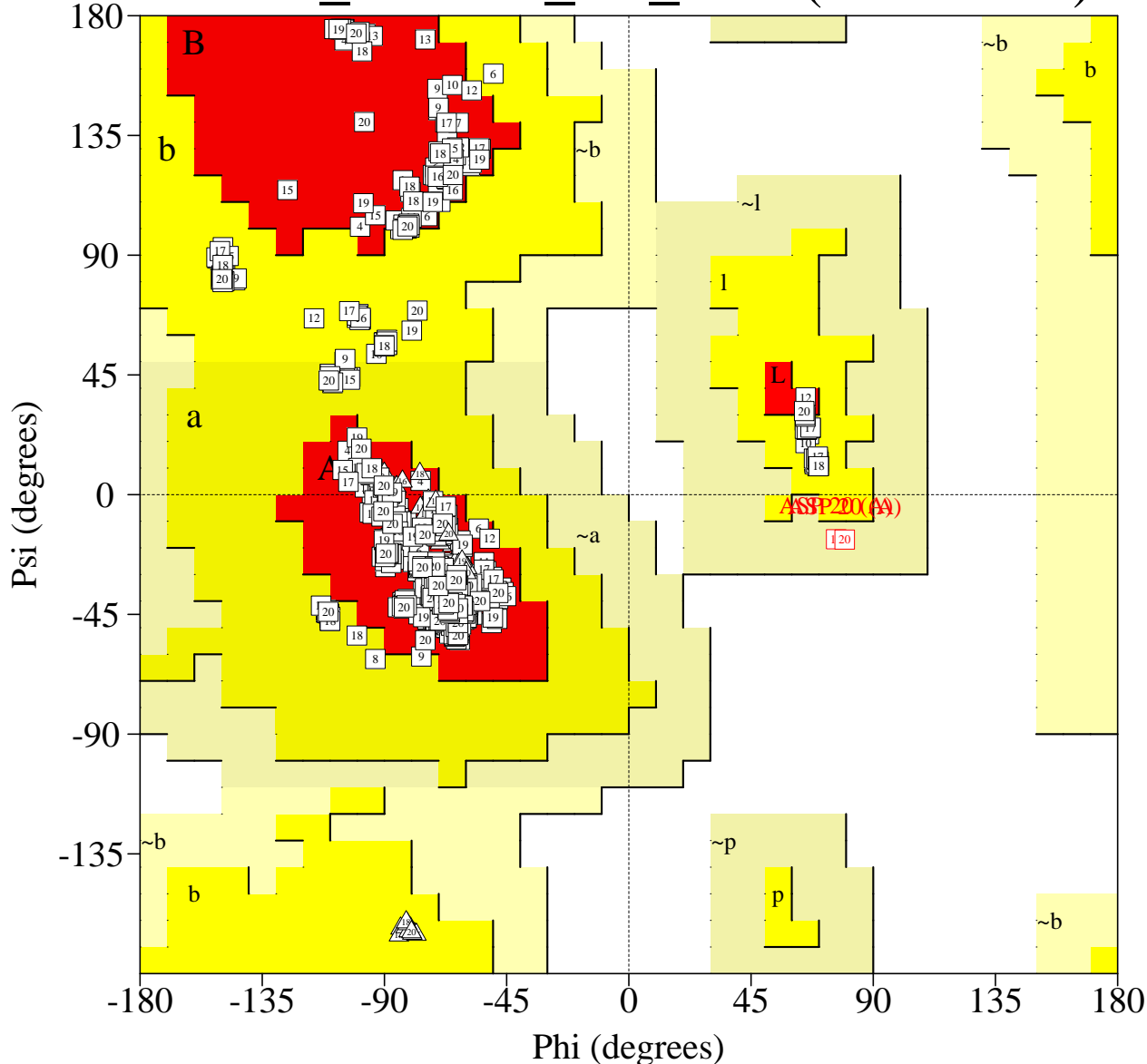


Ramachandran Plot
