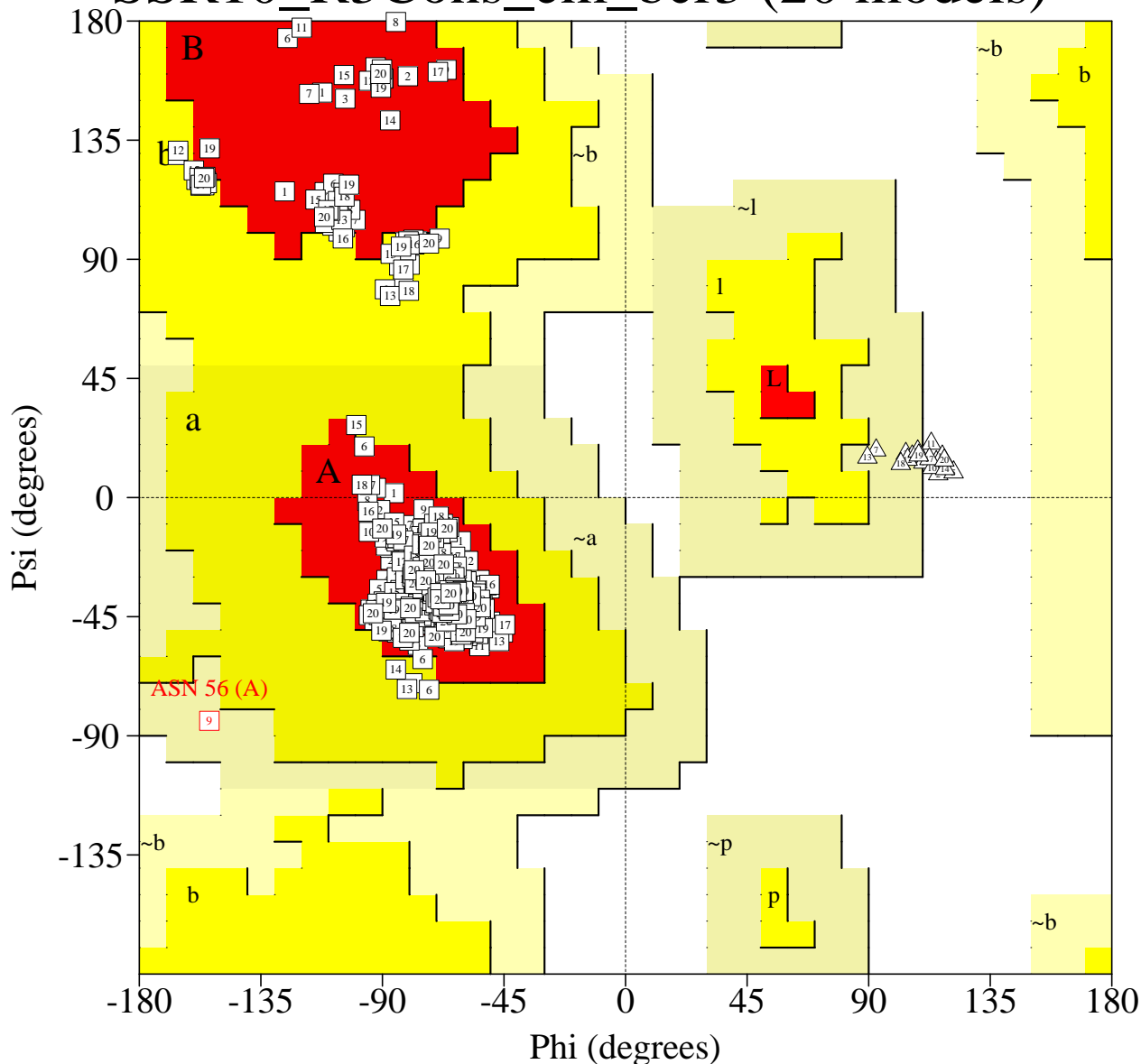


Ramachandran Plot
