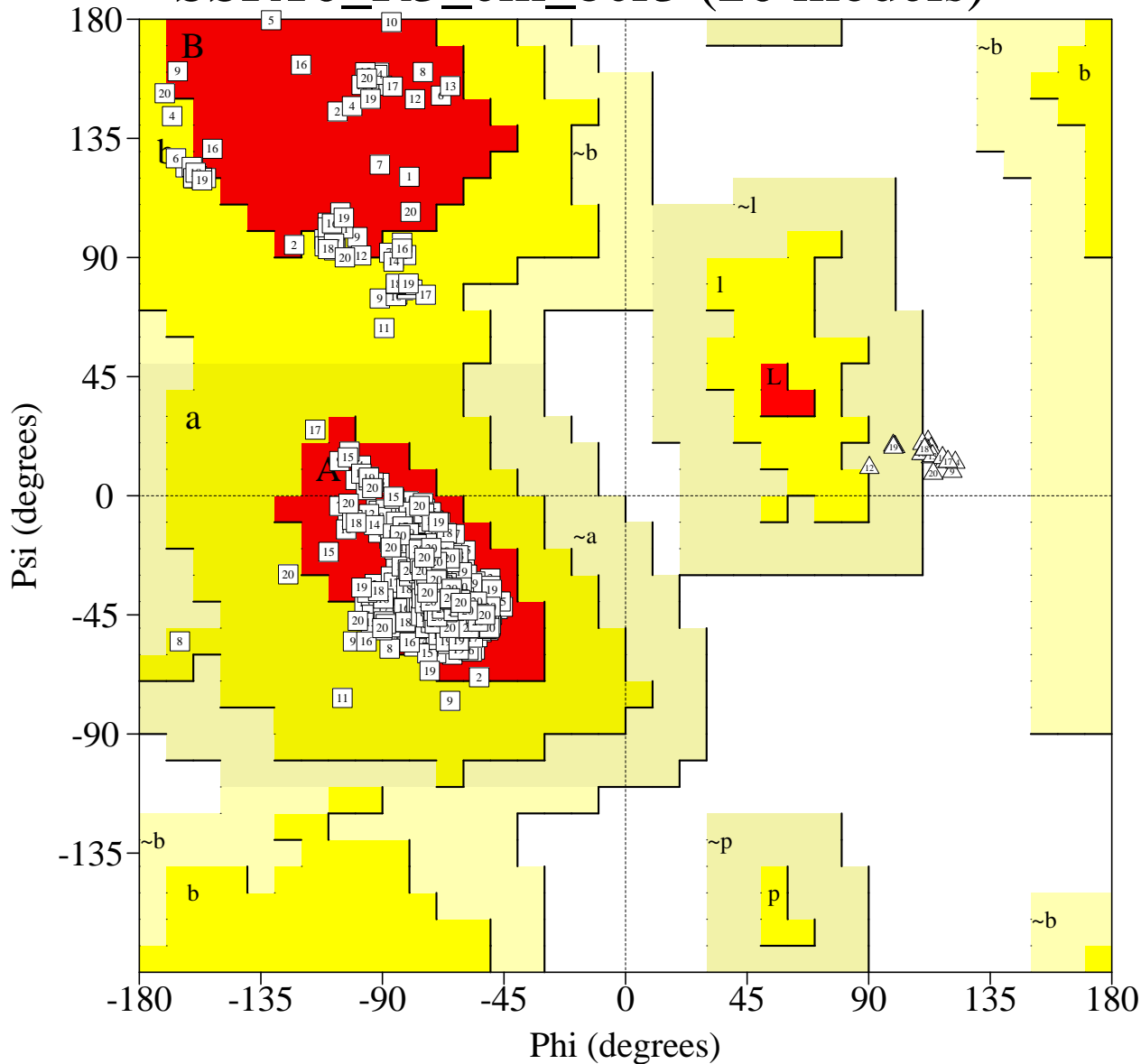


# Ramachandran Plot
