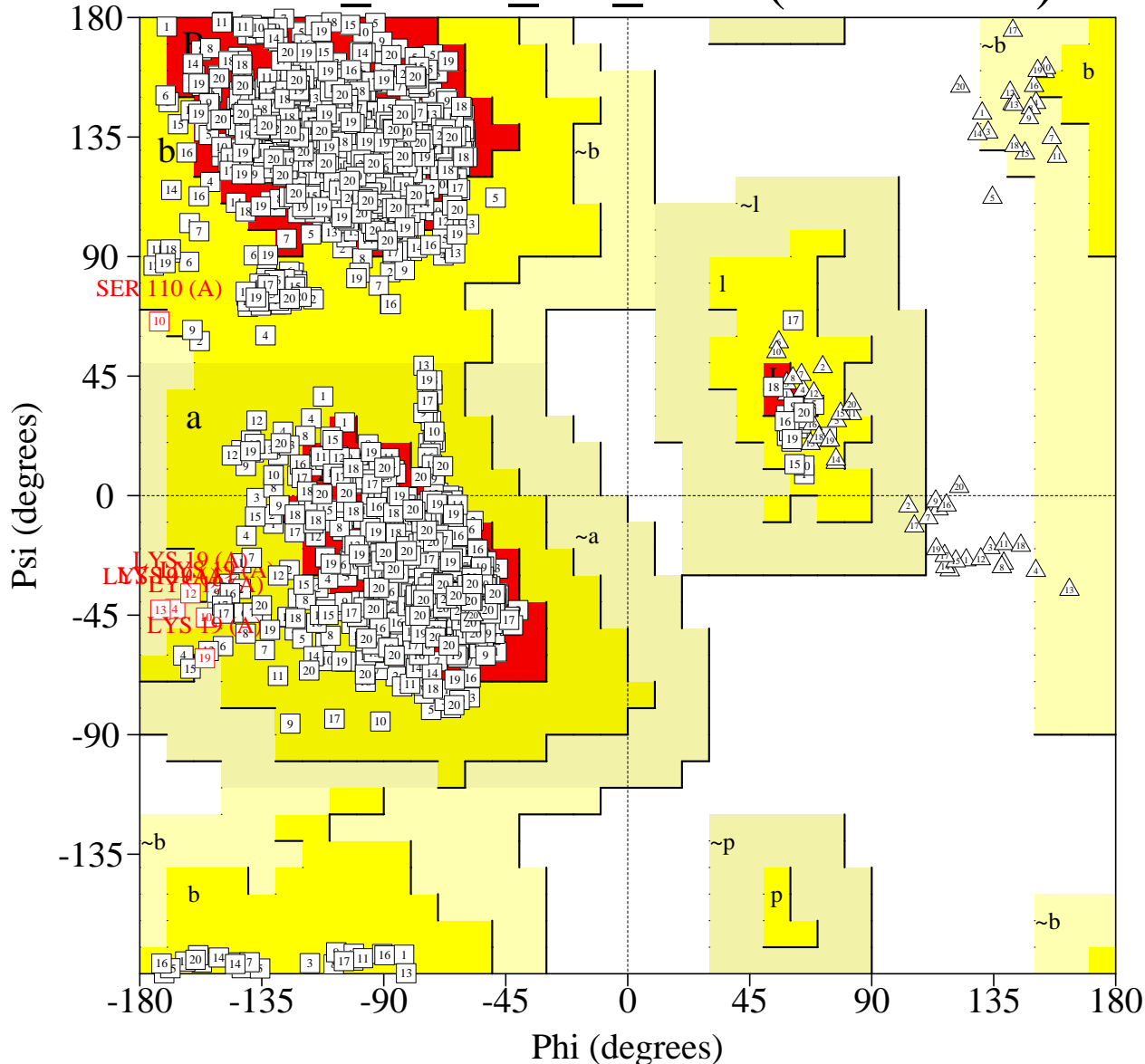


Ramachandran Plot
